## **Earthworks Paid Time Off Policy**

Effective January 1, 2018

In order to be in compliance with new state laws, the following Paid Time Off policies will be in effect January 1, 2018 as follows:

- Paid Time Off will be accrued at a rate 1 hour for every 40 hours worked.
- New employees, accrued time off cannot be used until 90 calendar days of employment.
- Up to 40 hours of unused Paid Time Off will be carried over to the following year.
- If you want to use Paid Time off, you need to mark your time card with how many hours you want to use.
- If you are going to be gone for more than 3 unscheduled days, a Doctor's note will be required.
- You can schedule Paid Time Off to use for vacations, appointments, etc. This needs to be scheduled and approved by Jim.
- After 3 years of service, 3 paid Holidays will be paid if the holiday falls on your normal working day. This will not affect your PTO totals (July 4<sup>th</sup>, Thanksgiving and Christmas).
